- Copy of the most recent grade report.
- Copy of Immigration Status letter (if applicable).
- Copy of Police Clearance Certificate no more than 6 months old.

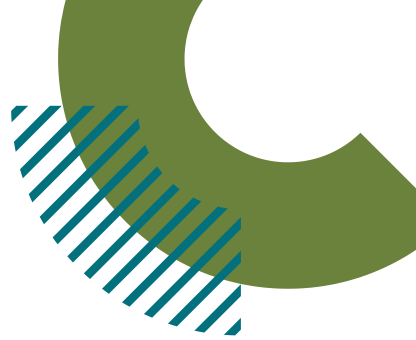
